### VNP CLEAN WATER JOINT POWERS BOARD MEETING November 16, 2022

The monthly meeting of the VNP Clean Water Powers Board was held at the Crane Lake chapel in Crane Lake. The meeting was called to order at 10:10 by Chairman Pavleck. Board members also present were Commissioner McDonald and Commissioner Sjoblom. There were no public comments.

A motion was made by Commissioner McDonald and supported by Commissioner Sjoblom to approve the October 26, 2022 minutes. All voted in favor.

### Ash River.

Approximately 90 soil borings have been completed. There are still a few areas were additional borings will be needed to further define bedrock locations. Good news is there is less bedrock that originally anticpated. The bad news is there are some very poor soils located around Ash Trail Lodge. Special design will be needed for grinder stations. Boring work is scheduled to be completed in November and December. Final design submittal to the MPCA is still on schedule for March 2023.

### Kabetogama.

The Township continued work with the soils consultant investigating potential treatment sites for the next project phase. SEH continues to get responses from the property owner questionnaires that were mailed out earlier this year. Facility Planning process will continue through the winter.

#### Crane Lake.

Jason provided an update from Rob Scott that construction will be wrapping up at the WWTP once winter sets in. Work will then resume in the spring of 2023.

## **Koochiching County**

No significant updates. Matt is discussing with the MPCA the potential use of CWC funds on a campground development project.

### VNP.

Bob reported that the MPCA recently reached out to him regarding previous houseboat gray water discussion topic. No other updates.
