VNP CLEAN WATER JOINT POWERS BOARD MEETING May 18, 2022

The monthly meeting of the VNP Clean Water Powers Board was held at the St Louis County Public Works Facility in Cook. The meeting was called to order at 10:06 by Chairman Pavleck. Board members also present were Commissioner McDonald, and Commissioner Nelson. There were no public comments and all attendees introduced themselves.

A motion was made by Commissioner Nelson and supported by Commissioner McDonald to approve the April 20, 2022, minutes. All voted in favor.

The Comprehensive Plan was revised to address some clerical edits and posted to the project website. (Dated April 2022). There were no further comments on the approved plan.

Ash River. No significant updates. Still trying to obtain easements from property owners. Costin group did provide an update that Ash River grant extension continues to move forward in legislation.

Kabetogama. There was an introductory meeting by SEH to the board on May 3. There will be another meeting to discuss the facility planning process on June 7th.

Crane Lake. WWTP project bid opening on May 19th. ISTS installations are currently on hold. Immediate concern is operations during current flooding conditions.

Island View. No significant updates. Contract A and C are complete. There are still some issues with Contract B.

DNR. Not in attendance

MPCA. David provide an update on status of Crane Lake and Kabetogama grants.

VNP. Bob reported no updates regarding clean water related topics. They are currently trying to operate under current flooding conditions.

Project Funding. Jason Chopp and Commissioner McDonald provided a recap on the May 2 CWC presentation. Costin group is requesting letters of support from the advisory committee members.
