VNP CLEAN WATER JOINT POWERS BOARD MEETING October 16, 2019

The monthly meeting of the VNP Clean Water Powers Board was held at the St. Louis County Public Works Building in Cook, MN on October 16,2019. The meeting was called to order at 10:14 by Chairman Pavleck. Board members also present were Commissioner Sjoblom, Commissioner McDonald and Commissioner Jugovich. Commissioner Pavleck welcomed everyone to the meeting and thanked all of the office and departmental representatives for attending. There were no public comments and all attendees introduced themselves.

A motion was made by Commissioner Sjoblom and supported by Commissioner McDonald to approve the September 23, 2019 minutes. All voted in favor.

Mark St. Lawrence provided an overview of the local 25% match obligations for each county in regards to the cost associated with the update the Wastewater Comprehensive Plan. The local match will be \$11,875 or \$5,937.50 equal split per county. A motion was made by Commissioner Jugovich and supported by Commissioner Sjoblom to approve the local match obligations for each county. All voted in favor.

Mark St. Lawrence provided requested the board determined how to obligate the \$47,500 Comp. Plan costs from the previously allocated funds to Ash River and Crane Lake. A motion was made by Commissioner Jugovich and supported by Commissioner Sjoblom to approve splitting the re-allocation of funds (\$23,750 each from Ash River and Crane Lake) to the Comprehensive Plan Project.. All voted in favor.

Ash River. Mark St. Lawrence informed the group that the St. Louis County Board selected 5 board members for Ash River. Deb Sanders is on the board and was present at the meeting. Deb indicated that the board intends to meet in early November. Jason provided Deb with the recent information packet update on the Ash River Facility Planning and Preliminary Design. A tentative meeting date between the Board and SEH is scheduled for November 14, 2019. Deb will confirm the date once the Ash Board holds their first meeting.

Kabetogama. Jason provided a brief review on the status of Phase 2 Kabetogama that John provided at the September 2019 meeting.

Crane Lake. No updates. Rob was not present.

Koochiching. The project is nearly complete with exception of 1grinder station and some additional work that may extend Contract A through the month of November. There is still a large amount of restoration work that is needed.

On November 14, the ARSSD Board had a conference call with SEH to review some preliminary items and provide an engineering updates on the Facility Plan process. A project update memorandum was developed and provided at the meeting (attached). As a follow-up to the meeting, SEH is going to contact Mia at Fryberger Law Firm to ask about potential fees for preparation of easement documents so that the District can begin to plan for future monetary needs. SEH is also going to send the district the contact information for Scott Harder, who was the financial analyst on the Kabetogoma and Island View Projects.

The purpose of this memo is to provide you with updates related to the Ash River Sanitary Sewer District (ARSSD) Collection and Treatment Systems project for the regular ARSSD meeting on November 14, 2019.

SCHEDULE

The project is currently in report phase. The report being prepared is called a Facility Plan and will review options for collection and treatment of sanitary sewer from the Ash River area. The Facility Plan is also required to include environmental, historical, and archaeological reviews. Based on the State's funding schedule, the Facility Plan will be submitted to the Minnesota Pollution Control Agency (MPCA) in March 2020.

FUNDING

Minnesota Clean Water Legacy Grant funds have been obtained for a portion of this project. The grant is in the amount of \$450,000, but includes a match of \$90,000 from St. Louis County's Environmental Trust Fund, for a total of \$540,000. These funds will be mostly expended by engineering and geotechnical services. Our budgeting indicates that the funds should get us through Facility Plan preparation and up to 75% Design completion. Additional funding will be needed to complete the design, bid, and construct the project, which is estimated at over \$10 Million in construction cost by preliminary estimates. The goal in obtaining funding is to set sewer rates at or below \$100 per month per EDU.

ADDITIONAL SERVICES NEEDED

In order to keep the project moving forward, the District will need the services of a Financial Advisor/Accountant and an Attorney. SEH can give recommendations from past projects if desired.

VNP CLEAN WATER JOINT POWERS BOARD MEETING September 23, 2019

The monthly meeting of the VNP Clean Water Powers Board was held at the Kabetogama Town Hall on September 23, 2019. The meeting was called to order at 11:00 by Chairman Pavleck. Board members also present were Commissioner McBride, Commissioner McDonald and Commissioner Jugovich. Commissioner Pavleck welcomed everyone to the meeting and thanked all of the office and departmental representatives for attending. There were no public comments and all attendees introduced themselves.

A motion was made by Commissioner McBride and supported by Commissioner Jugovich to approve the August 21, 2019 minutes. All voted in favor.

Jason Chopp provided an overview of the SEH proposal for \$47,500 to update the Wastewater Comprehensive Plan. A motion was made by Commissioner McDonald and supported by Commissioner McBride to approve the SEH proposal contingent on the services being eligible for reimbursement through their existing clean water grant funding. All voted in favor.

Ash River. There were 6 applications for the 5 board of manager positions. The appointments to be made at the October 1, 2019 St. Louis County Board Meeting. SEH provided an update on the Ash River Facility Plan progress. Preliminary EDU's have been established based on the initial service area. SEH has found that there is approximately 231.3 EDU's in the proposed area. This number is subject to change once reviewed by the newly formed sanitary board of managers.

Kabetogama. John provided an update that the petitions have been completed for the 5 proposed areas and will be working with the Township to establish the new districts. The areas to be considered are C, F, G, H, and possibly J. Areas J1, A, and D would be considered as Phase 3 later on. The next steps for the district is to request funds and budgets to move phase 2 forward. Gary stated that Kabetogama would be requesting money from the 2021 funding cycle. John thought the Comprehensive Plan Update will help the district better understand the Phase 2 Project costs but further funding will be needed for preliminary engineering to solidify those numbers.

Crane Lake. ISTS installations are ongoing and work continues on the Management Program. Work on the Kicker Blvd. project has been put on hold due to manpower constraints. ISTS installations are anticipated again for the 2020 construction season.

Koochiching. The project is 95% complete. There are only a handful of grinder stations that remain to be installed and plenty of clean up and restoration work. Punchlists and substantial completion for Contracts A and B should be issued in October 2019.

DNR. Nothing to report.

MPCA. Nothing to report.

VNP. Bob stated that vegetation is establishing well on the areas restored around the visitor's center. Bob has provided input to John regarding the VNP area located within proposed Area G in the Phase 2 Project.

Mark St. Lawrence was not present with current invoices. Invoices will be approved at the October 2019 Meeting.

John Stegmeir stated he will be out of the area for an extended period of time and that an alternate individual from Kabetogama will be attending the JPB meetings. He will be available via phone or email during this time.

VNP CLEAN WATER JOINT POWERS BOARD MEETING August 21, 2019

The monthly meeting of the VNP Clean Water Powers Board was held at the Crane Lake chapel on August 21, 2019. The meeting was called to order at 11:00 by Chairman Pavleck. Board members also present were Commissioner Sjoblom and Commissioner Nelson. Commissioner Pavleck welcomed everyone to the meeting and thanked all of the office and departmental representatives for attending. There were no public comments and all attendees introduced themselves.

A motion was made by Commissioner Nelson and supported by Commissioner Sjoblom to approve the July 17, 2019 minutes. All voted in favor.

There was a discussion regarding the upgrading of the Comprehensive Plan. Each area needs to provide updates to S.E.H. Additionally, Saint Louis County Environmental Services will be providing an update on the sewer generating parcels on record. Commissioner Nelson emphasized that the public should have the opportunity to provide input and that the elected body for each area should have the opportunity to review and endorse the updated plan for their area. A motion was made by Commissioner Nelson and supported by Commissioner Sjoblom to do a desk top vs assessment approach with the update process. All voted in favor.

Ash River. Initial field surveys and soil borings were completed in July. S.E.H. will be working on EDU assignments and design flows. The feasibility study is in work and anticipated to be complete in March 2020. There were 6 applications for the 5 board of manager positions. The appointments to be made at the September SLC Board meeting.

Kabetogama. The Puck's Point project is complete and final payment has been processed. Work continues on identifying the next service areas. The petitions have been completed for the 5 proposed areas and will be working with the Township to establish the new districts.

Crane Lake. ISTS installations are ongoing and work continues on the Management Program. Work on the Kicker Blvd. project has been put on hold due to manpower constraints.

Koochiching. The Island View extension project work is in full construction. The new expected completion date is September due to the changes in the scope of work.

The purpose of this memo is to update the Board on the status of the Facility Plan preparation for the Ash River area. SEH sent questionnaires to property owners in the area of the proposed project in January, 2019. We received responses from most of the property owners, which detailed existing home/cabin configurations, existing septic system configurations, and any plans to make changes to their property in the future. In order to further clarify and to investigate those properties from which we had no response, SEH had representatives on site July 17, and 18. We reviewed each property and collected information to help us determine how each property would be best served by a community sewer.

During the same period SEH had survey crews on site to identify property lines so that we have a better idea of how to draw up easements on the properties in the future. We also had a subcontractor, Braun Intertec, on site to conduct 41 soil borings along Ash River Trail. Braun was instructed to drill to refusal or to a 10-ft depth if they could get there. Surprisingly, and for the benefit of the project, 36 of the 41 borings went the full depth of 10 feet. This is good news because the main forcemain will likely not need to be installed through rock, saving significant construction cost. Additional soil boring work will be done during the design phase and after individual easements have been drawn up and approved for each property.

The information we have gathered to this point has allowed us to develop a preliminary EDU Table. We've found that there are approximately 231.3 EDUs in the project boundary. This number will change as the Sanitary District makes determinations about the boundaries for the project and solidifies EDU assignments. We will continue to evaluate properties to determine a design flow for the collection and treatment systems. After a design flow has been set, a Preliminary Effluent Limit request will be sent to MPCA in order to get input on the limits for which we'll need to design the treatment system to meet.

Since not every property will be best served by a community collection system, we have also done a preliminary evaluation of each property to see if an on-site treatment system (septic system) could be constructed on their property. We did this by assuming an average flow and corresponding average mound size. We then laid the mound footprint over each property do determine if it would fit, and also if a backup mound system would fit, which is required by Minnesota Rules for new systems. The results of our findings are summarized in the EDU table attached to this memo.

VNP CLEAN WATER JOINT POWERS BOARD MEETING May 15, 2019

The purpose of this memo is to update the Board on the status of the Facility Plan preparation for the Ash River area. At this time, the Facility Plan is not complete enough to meet the March 1, 2019 deadline for submittal to MPCA for review. SEH recommends delaying submittal until the end of 2019 or early 2020 in order to allow for further communications with residents and property owners in the area.

SEH was given authorization to proceed with the project in November 2018. We immediately began by conducting a drone survey, compiling survey data, and creating exhibits of each piece of property to send to property owners. These exhibits were sent to property owners, along with a letter and questionnaire in early January 2019. The purpose of these mailings were to attempt to gain more information about existing systems so that we may begin to plan pipe routing and estimation of design flows. Unfortunately, only 48 out of 173 questionnaires have been received as of Monday, February 25, 2019. Communication with each property owner is important prior to completing preliminary pipe layout and treatment system design options.

Additionally, we also wanted to inform you about changes in the Clean Water Revolving Fund Facility Plan requirements. Several items were added to the list of requirements in 2018. I have attached a copy of the CWRF Facilities Plan Submittal Checklist for your information.

Some of the items on the checklist require that the Facility Plan and cost information be reviewed by the governing body. The Facility Plan submittal, in order to be complete, would have to occur after the establishment of the Sanitary Sewer District, and the District would need to review those items listed in the Checklist. If the Sanitary Sewer District is not yet formed by the time the Facility Plan is submitted, St. Louis County may act as the governing body. We may also amend the facility plan at a later date to add information after the establishment of the Sanitary District.

Utilizing the 2019 summer months for in-person meetings with property owners, completion of soil borings, and establishment of the Sanitary Sewer District, will allow for a Facility Plan report that is complete and in the best interest of the property owners. Our next step will be to schedule these tasks, starting in the spring of 2019.

VNP CLEAN WATER JOINT POWERS BOARD MEETING October 17, 2018

The monthly meeting of the VNP Clean Water Powers Board was held at the Town Hall in Kabetogama on October 17, 2018. The meeting was called to order at 10:06 by Chairman Pavleck. Board members also present were Commissioner Jugovich and Commissioner Rukavina.

Commissioner Pavleck welcomed everyone to the meeting and all in attendance introduced themselves. There were no public comments.

A motion was made by Commissioner Rukavina and supported by Commissioner Jugovich to approve the September 19, 2018 minutes. All voted in favor.

Kabetogama. The Pucks Point sewer project is under the warranty period. The contractor has to perform a repair to a grinder station under project warranty, USA Construction indicated that this work would be completed in the fall of 2018. There was a neighborhood meeting on August 29th to discuss the follow on phases to the sewer system. John indicated that there were 11 volunteers to be on a project steering committee. The next steering committee meeting is scheduled for October, followed by a meeting with the attorney in December to discuss district formation options.

Ash River. S.E.H. will start on the facility planning phase for the Ash River sewer project once the grant funding paperwork is finalized with MPCA. In September, the MPCA again asked S.E.H to revise and resubmit the work plan for Ash River, S.E.H has made the requested revisions and the work plan has been resubmitted to the MPCA with no response to date. There was discussion for permission for Gary to draft a letter for the MPCA expressing concerns on approval delay and timeline to complete a facility plan by March. A motion was made by Commissioner Rukavina and supported by Commissioner Jugovich to approve sending the letter and allowing Wade to sign the letter. All voted in favor. Mark stated that the 40 day comment period for the resolution to form a sewer district has passed and the county will be sending the formal notification to the state in the near future.

Crane Lake. The Handberg Road expansion project is nearly complete with some additional restoration work to be completed. The 2018 construction season is complete with a total of 32 ISTS systems installed within the district under the

management program. The district estimated an additional 10-15 ISTS systems to be installed in 2019.

Koochiching. Contracts A, B and C are proceeding along. Lift Station 100, 200 and 300 are operational. Lift Station 400 is scheduled to go online in early November. The grinder station installations are underway for both Contracts A and B. Installations are anticipated to continue until the end of the construction season. Matt indicated that the assessment hearing for the project took place in September and the assessment has been approved by the county board.

There was a motion by Commissioner Rukavina to pay the Costin and S.E.H. invoices. It was supported by Commissioner Jugovich. All voted in favor

VNP. Bill was happy with the progress and communication so far with the construction of Contract C. Bob indicated that there was a new Facilities Chief at the Park and that he will join in at the next JPB meeting to introduce himself.

VNP CLEAN WATER JOINT POWERS BOARD MEETING January 17, 2018

The monthly meeting of the VNP Clean Water Powers Board was held at Cook Land Office January 17, 2018. The meeting was called to order at 10:00 by Chairman Pavleck. Commissioner Rukavina, Commissioner Nelson, and Commissioner McBride were also present. Introductions were made and there were no public comments.

A motion was made by Commissioner Rukavina to approve the minutes of the October 27, 2017 and December 20, 2017 minutes for the JPB meeting. Commissioner McBride supported and all voted in favor.

Kabetogama. John was not present. Colin Marcusen provided the project update. The dispersal and collection system projects are complete. Only warranty work and spring restoration work is left to be done. Commissioner Rukavina inquired about how much funding remains from the additional \$50,000 that was allocated to the project. Colin indicated that approximately \$28,000 of funding remains.

Ash River. SEH provided an update regarding the differences between developing a Facility Plan or CAR for Ash River. Essentially the content is nearly identical. A Facility Plan can be relabeled as a CAR depending on which project funding source is being perused. The main difference is the whether or not the JPB would like to include the University of Minnesota in the process. SEH provided a contract to Mark St. Lawrence to proceed with the Facility Plan. Colin noted that the Kabetogama project started out as a Facility Plan and was later changed to a CAR based on the desired project funding. Mark expressed his concern with the County being able to perform an adequate amount of in-kind services as local match to the \$450,000 legacy grant. Mark will continue work with SEH in finalizing the scope of work so a contract can be presented to the Commissioners for approval. Commissioner Rukavina made a motioin to request the JPB send out a letter to Ash River residents requesting volunteers to serve on an Ash River Sewer Committee. Gark Cerkvenick will assist in drafting the letter and Mark St. Lawrence will mail out the letter. Commissioner McBride supported, all in favor. Commissioner Pavlek made a motion to have the county submit a IRRRB funding application and PPL application for the Ash River Project. Commissioner Rukavina supported, all in favor.

Crane Lake. Rob was not present. Jason provide an update that The Handberg Road project added 2 additional grinder station connects. 8 of the 10 grinder

stations have been installed. The contractor has shut down for the winter, but will return to complete the installation of the final 2 grinder stations and complete restoration work by June 2018. In the summer of 2018 the district intends to start the annexation process for Kicker Blvd.

Koochiching. Dale provided an update that the Island View project is in winter construction shut down. No more work is anticipated until the April/May 2018 timeframe. Contract A has completed approximately \$3.8 million (40%) in work through November. Contract B has completed \$1.7 million (24%) in work through November. The first lift station is anticipated to be operational for grinder connections in July 2018. The contractual construction completion of the project is summer of 2019.

VNP. Bill Johnson provided a VNP update. He indicated that they are currently working with the County and SEH on potentially relocated the proposed sewer lines as part of the Island View Sewer Project to minimize the impact on the new asphalt parking lot and driveway.

Kabetogama

The construction portion of the project is taking shape.

- Dispersal contractor, Viita's Excavating has cleared trees in dispersal and pretreatment areas. Dispersal and Pretreatment work will begin late May or early June.

The soil analysis from Matrix Soils is complete for the potential treatment site and the data looks favorable. We request that the land swap between the County and DNR continue to proceed based on this information.

VNP CLEAN WATER JOINT POWERS BOARD MEETING March 16, 2016

The monthly meeting of the VNP Clean Water Powers Board was held at the Cook Land Department on March 16, 2016. The meeting was called to order at 9:30 by Chairman Pavleck. Board member present were Commissioners McBride, Rukavina, and Pavleck. There were no comments from the public.

A motion was made by Commissioner McBride to approve the minutes of the January 20, 2016 JPB meeting. Commissioner Rukavina supported and all voted in favor.

Kabetogama. The construction portion of the project is taking shape. The preconstruction meeting was held on February 26, 2016. DNR executed a lease agreement with Kabetogama for the treatment site. A meeting will be held in Grand Rapids with DNR to discuss the Kabetogama project. John Stegmeir discussed the challenge to get a licensed operator to run the treatment plant. Rob Scott added that at Crane Lake they are experiencing the same problem. Dale Olson said he would assist.

Koochiching. With the awarding of the \$4.5 million dollar grant from the USACE there is still a \$1.5 million dollar shortfall. The current plan, as discussed by Gary Cerkvenik, was to get the additional funds for the project from the State Bonding Bill. If funding falls into place the target date for construction is spring of 2017.

Ash River. The soil testing results look promising for construction of the treatment plant. There is a meeting scheduled with DNR to discuss the Ash River project and DNR lands.

Crane Lake. Rob Scott discussed the status of the Handberg Road extension. Work continues on the CAR and some punch list items. Both will be done in the spring. Phase II of the project is in work with summer of this year the target to complete. He also discussed the East Bay management program and the Kicker Boulevard annexation. The county will review the area for a possible expansion of the Comprehensive Plan scope of work.

A topic of discussion at this meeting was the DNR's responsibility for paying capital costs related to the construction of this infrastructure. There was a misunderstanding regarding the currently estimated fee and this letter is intended to provide clarification. The capital cost fee for Woodenfrog Campground is currently estimated at \$64,175.56.

Woodenfrog Campground is part of the Puck's Point Subordinate Service District, the entity completing the improvements for the betterment of their community. As such, the Campground (or DNR), is being charged capital fees just as the other members of the District. The estimated fee is based on 10 equivalent dwelling units (EDUs) for the Campground and totalized capital fees over the 20-year loan term. The fee is subject to change based on the amount of grant available to the project, which is currently under discussion at the Minnesota State Legislature. Billing will be finalized during the summer of 2016. The current estimated sources and uses of funds for the project are summarized in the attached table.

Payment of the capital portion of the fees and connection of the Campground to the new treatment system were further emphasized by law written into Bonding Bills in 2013 and 2014. Kabetogama Township will accept partial payment, monthly payments, or payment in full of the capital portion of the costs related to construction of this infrastructure when billing is finalized.

VNP CLEAN WATER JOINT POWERS BOARD MEETING January 20, 2016

The monthly meeting of the VNP Clean Water Powers Board was held at the Cook Land Department on November 18, 2015. The meeting was called to order at 10:00 a.m. by Chairman Pavleck. Board member present were commissioners Rukavina, and Pavleck; Commissioner McBride was available via telephone. There were no comments from the public.

A motion by Commissioner Rukavina and seconded by Commissioner McBride to approve the November 18, 2015 minutes, all voted in favor.

Project Funding: The 569 Application has \$55 million nationwide annual funding. It has been asked of Representative Nolan to ask the secretary to fund the project (\$4.5 million) with the additional money.

Kabetogama: The application for Legacy Funds has been submitted to Mike Kennedy at MPCA and is under review. Contracts will need to be signed. The PFA recommended delaying loan application (MN Rural Waters Fund) until funds are needed to prevent unnecessary financing charges. Contracts have been secured with all 3 contractors. In the Winter, 2015/2016 easement documents will be prepared – joint effort between SEH and the Township's attorneys. Easements will be mailed to District members for signature. Work with DNR to secure capital contribution and determine schedule for hookup. From May – July, 2016, construction of pretreatment and dispersal systems will take place. From September – November 2016 the construction of collection system and completion of pretreatment and dispersal systems will take place.

Koochiching. Dale Olson reported that there is a "lull" in the action awaiting funding. The JPB has requested that Koochiching provide a package of the support letters received to date to have the Chair forward them under JPB cover to our elected officials and interested parties.

Ash River. The Soil Testing with Matrix said that the soil looks promisable in on the parcel that is most suitable for the project.

Crane Lake. The Handberg Road expansion is complete. Contractor has been paid everything but the 5% retainage. Once the punch list items are done in the spring the district will issue final payment. District is continuing to work on the Community Assessment Report for Handberg Road area and will pursue connections or replacements of the noncomplying systems. Work continues with the DNR on Special Use permits for the two DNR landings. The District is working with the USFS regarding the recreational residences in East Bay having the option of a managed ISTS installed. Work is in the early stages to expand the CLWSD by annexation of the Kicker Boulevard area on Sandpoint Lake.

DNR: The Woodenfrog campground in Kabetogama is currently School Trust Fund Land and will be leased to Kabetogama for the sewer project. It was discussed by Commissioner Rukavina that Kabetogama should sign the lease, but going forward, the county should work with the DNR to do a permanent land exchange for this area, with revocable money from the lease.

Gary Cerkvenik discussed the proposal for bonding money and that it should be lowered to a 25% Match. The proposed bill is asking for \$6.2 Million, with flexibility for any project within the VNPCWP.

The meeting was adjourned at 11:00 am, the next meeting is set for 10:00 am at the Cook Land Office building on March 16th.

Thank you for your response on December 14, 2015 to our letter regarding funding for the Voyageurs National Park (VNP) Clean Water Project under the Fiscal Year (FY) 2016 Army Civil Works program budget. With the passage of appropriations legislation for FY 2016, we again urge the U.S. Army Corps of Engineers (USACE) to support the VNP Clean Water Project as it allocates funds for environmental infrastructure projects.

VNP was authorized by Congress in 1971 and formally established in 1975. It is a national treasure, with 84,000 acres of water and 134,000 acres of land enjoyed annually by thousands of visitors from across the United States, Canada, and other countries. As elected officials representing Minnesota, we are rightly concerned about protecting the water quality of our nation's premier water-based Park. Unfortunately, these waters can be contaminated by wastewater from existing developments. The water quality degradation threatens the long-term health of the ecosystem and the economic health of the tourism industry upon which a considerable share of the local economy is based.

The VNP Clean Water Project is critical for Minnesotans in the rural areas of Koochiching and St. Louis Counties where poverty far exceeds the statewide rate. In addition to the jobs and regional economic impact accompanying this project, it would provide higher water quality and long-term wastewater treatment solutions.

In the FY 2016 omnibus, Congress provided an additional \$55 million for environmental infrastructure projects such as the VNP Clean Water Project. Furthermore, Congress instructed to USACE to prioritize environmental infrastructure projects with great economic impact, projects in rural communities, and projects in counties with high poverty rates. Based on these factors and the numerous benefits to Minnesota's environment and rural economy, we ask you to allocate environmental infrastructure funding to this project.

Thank you for your consideration of this request. We look forward to your response and to working with you to move the VNP Clean Water Project forward.
